Tsaib no cov tub ntxhais kawm hauv Twin Rivers Unified Koog Tsev Kawm Ntawv (TRUSD) nce 20 qhab nees ntxiv hais txog lub xeev tus Academic Performance Index (API), uas ntsuas txog kev kawm tau. Muaj ib lub hom phiaj xav kom nce ntau tshaj qhov qub xyoo no, TRUSD tau kho lawv lub tswv yim hu ua Local Education Agency (LEA) thiab ua tiav lawv lub tswv yim los txhim kho Program kom zoo ntxiv. Ib lub "LEA: yog ib koog tsev kawm ntawv. TRUSD kuj tau faib cov nyiaj hu ua Title 1 ntxiv mus rau cov tsev kawm ntawv qhov tseem ntsiab yog xav txhawb nqa kom txhua tus me nyuam kawm kom cuag qib theem hu ua proficiency thiab txhob poob qab hu ua closing the achievement gap.

Cov tsev kawm ntawv Elementary thiab cov tsev kawm ntawv Secondary cov kev cai kawm txuj/Tsis pub ib tug me nyuam poob rau tom qab (No Child Left Behind Act) xyoo 2001 (ESEA/NCLB) yuav kom tag nrho txhua lub xeev los tab lawv cov qauv (standards) hais txog kev kawm txuj kom siab uas ib tug me nyuam yuav tsum paub thiab yuav tsum ua tau nyob rau txhua qib hais txog Askiv thiab zauv. Txhua lub tsev kawm ntawv yuav tsum muaj kev vam meej zuj zus mus ntxhua txhua xyoo kom txog rau thaum tag nrho cov me nyuam kawm ntawv no ncav cuag cov qauv (standards). Txoj kev vam meej nyob rau ib xyoo twg ntawm cov tsev kawm ntawv no hu ua Adequate Yearly Progress (AYP).

ESEA/NCLB kuj yuav kom lub California Department of Education (CDE) los saib txhua txhua xyoo seb ib koog tsev kawm ntawv (LEA) ua tau zoo npaum li cas cov uas tau txais thooj nyiaj hu ua Title I, Part A. Ib koog tsev kawm ntawv hu ua LEA uas tau txais thooj nyiaj hu ua Title I, Part A, txheeb tau tias yog Program Improvement (PI) yog hais tias nws tsis ncav AYP cov hom phiaj li ob xyoo ua ke hauv ntu Askiv thiab ntu zauv.

ESEA/NCLB yuav kom lub CDE los hais qhia rau cov niam cov txiv/tus neeg saib xyuas ntawm cov me nyuam kawm ntawv hais txog koog tsev kawm ntawv (LEA) seb lawv qhia zoo li cas. - Tseg yam tsawg los kaum feem pua ntawm cov nyiaj Title I los muab kev txhim kho yam muaj kev txawj ntse rau cov kws qhia ntawv thiab cov neeg khiav hauj lwm (administrators).
